NOTICE OF RACE

The notation '[NP]' in a rule of the notice of race means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

ORGANIZING AUTHORITY

The organizing authority for the event is Mount's Bay Sailing Club in conjunction with the RS Class Association.

1 RULES

- 1.1 The event is governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 Racing rules 29.1, 33, 34, 35, 60.1(a), 60.1(b), 61.3, 62.1(a), 62.2, 63.1, A2, A4, A5.1 and A5.2 and Race Signals AP will be changed. The changes appear, in full, in this notice of race or in the sailing instructions. The sailing instructions may also change other racing rules.
- 1.3 When a gate start is used, RRS 29.1 (individual recall) does not apply.
- 1.4 RRS 40.1 shall apply at all times while afloat.
- 1.5 [NP] [DP] Boats will be required to display an identification number (to be issued at registration) on each side of the bow.
- 1.6 [NP] [DP] Boats must have on board a rope specifically for towing purposes only. This rope must be not less than 10 metres in length and not less than 8 mm in diameter.

2 SAILING INSTRUCTIONS

The sailing instructions will be available at registration and may be available on the organizing authority's and / or class website beforehand.

3 COMMUNICATION

- 3.1 The official noticeboard is located in the Mount's Bay Sailing Club dinghy pen adjacent to the race office.
- 3.2 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4 ELIGIBILITY AND ENTRY

- 4.1 The event is open to boats of the RS200 class.
- 4.2 The helm must be a full, honorary, family, youth or block member of the RS Class Association and the crew must be a full, honorary, family, youth, block member or crew member of the RS Class Association, except where the helm has a valid 'any crew' extension to their membership.
- 4.3 Eligible boats may enter by completing the online form at <https://www.rs200sailing.org/championships/index.asp?eid=2487>.
- 4.4 To be considered an entry at the event, a boat shall complete all registration requirements and pay all fees.
- 4.5 Competitors aged under 18 shall complete an Under 18s Consent Form. This can be downloaded from the [RS Class Association website](#) and should be completed and handed in at registration.
- 4.6 The closing date for entries is 28 July 2024. Entries after this date are at the discretion of the organizing authority and must be made in writing (contact sally@rs-association.com).
- 4.7 The number of boats entering the event will initially be restricted to 150. The organizing authority may increase the number of permitted entries at its absolute discretion.
- 4.8 The organizing authority may cancel the event and reject or cancel entries at its absolute discretion, subject to RRS 76.
- 4.9 Should the organizing authority cancel or reject an entry they shall refund the entry fee in full.
- 4.10 Should the organizing authority cancel the event within 36 hours prior to the scheduled start of race one any refunds will be at the sole discretion of the organizing authority.

5 FEES

Entry fees are:

Early entry fee (until 5 May 2024) £295

Standard entry fee £345

6 CREW LIMITATIONS

Does not apply.

7 ADVERTISING

[DP] [NP] Boats may be required to display advertising chosen and supplied by the organizing authority.

8 QUALIFYING SERIES AND FINAL SERIES

Does not apply.

9 SCHEDULE

- 9.1 Registration will take place in the Mount's Bay Sailing Club clubhouse on Sunday 4 August 2024 from 0930 to 1800 and on Monday 5 August 2024 from 0900 to 1000.
- 9.2 A Briefing will be held in the Mount's Bay Sailing Club clubhouse on Sunday 4 August 2024 at 2000.

9.3 Schedule of races:

9.4 On the last scheduled day of racing no warning signal will be made after 1500.

9.5 The race committee may change the schedule of races due to weather conditions or other causes.

10 EQUIPMENT INSPECTION

10.1 Boats may be inspected at any time.

10.2 The fact that race officials may conduct inspections of a boat does not reduce the responsibilities of each competitor set out in this notice of race.

11 CLOTHING AND EQUIPMENT

Does not apply.

12 VENUE

Racing will take place in Penzance Bay, known locally as Mount's Bay, generally to the south and west of St. Michael's Mount. Admiralty Chart SC2345 covers this area.

13 COURSES

13.1 The courses to be sailed will be Windward Leeward.

13.2 Gate starts are intended.

14 PENALTY SYSTEM

The Post Race Penalty and the RYA Arbitration Procedures of the RYA Rules Disputes Procedures will be available. See the official notice board for details. Decisions from arbitration can be referred to the protest committee but cannot be reopened or appealed.

15 SCORING

15.1 Two races are required to be completed to constitute a series.

15.2 (a) When fewer than four races have been completed, a boat's series score will be the total of her race scores.

(b) When from four to seven races have been completed, a boat's series score will be the total of her race scores excluding her worst excludable score.

(c) When from eight to ten races have been completed, a boat's series score will be the total of her race scores excluding her two worst excludable scores.

This changes RRS A2.

16 SUPPORT PERSON VESSELS

[DP] [NP] No support vessels will be permitted at this event.

17 CHARTERED OR LOANED BOATS

Does not apply.

18 BERTHING

[DP] Boats shall be kept in their assigned places in the dinghy park.

19 HAUL-OUT RESTRICTIONS

Does not apply.

20 DIVING EQUIPMENT AND PLASTIC POOLS

Does not apply.

21 DATA PROTECTION

21.1 Competitors' and support persons' personal information provided to the organizing authority will be used to facilitate participation in the event. The legal basis for processing that personal information is contract. Personal information will be stored and used in accordance with the organizing authority's privacy policy, which is published on its website at mbsc.org.uk. When required by the rules, personal information may be shared with the Royal Yachting Association and / or World Sailing. The results of the event and the outcome of any hearing or appeal may be published.

21.2 The Class Data Processing Policy is available on the class website.

21.3 Competitors and support persons grant to the organizing authority without payment the right in perpetuity to make, use and show any motion pictures, still pictures and live, taped or filmed television of or relating to the event.

22 RISK STATEMENT

RRS 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone".

Sailing by its nature is an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

(a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event.

(b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore.

(c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions.

(d) Their boat is in good order, equipped to sail in the event and they are fit to participate.

- (e) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities.
- (f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions as can be practically provided in the circumstances.
- (g) It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules or information produced for the venue or event and to attend any safety briefing held for the event.

23 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3,000,000 per incident or the equivalent.

24 PRIZES

24.1 The overall winner(s) of the championship fleet series will be awarded the first-place trophy and title National Champion(s).

24.2 Other prizes may be awarded, dependent on entries and at the discretion of the organizing authority, as follows:

- Top 10 places overall
- Silver division 1st 3 places
- Bronze division 1st 3 places
- 1st Lady Helm
- 1st Lady Team
- 1st Master Helm (45 or older at start of championships)
- 1st Grandmaster helm (60 and over)
- 1st Youth Helm (22 or under at start of championships)
- 1st Youth Team (22 or under at start of championships)
- 1st Youth Crew (22 or under at start of championships)
- 1st Junior Team (18 or under at start of championships)
- 1st Junior Helm (18 or under at start of championships)
- 1st Junior Crew (18 or under at start of championships)
- Loving Cup (1st couple)
- 1st Family (parent and child)
- Top Club (best placed 3 boats from any one club - first named club on entry only)
- Top Uni (best placed 3 boats from any one Uni - first named Uni on entry only)
- Top Buddy Group (best placed 3 boats from 1 buddy group)

25 DINGHY PARK

Motor vehicles shall not be parked in the dinghy park. Competitors and / or support persons shall not camp or sleep overnight in the dinghy park or the Mount's Bay Sailing Club dinghy pen.
